

ALOHA SHRINERS BEACH CLUB RENTAL
INFORMATION, RULES, AND REQUIREMENTS

General information:

The facility is available for rentals only on Saturdays, from 8am to 5pm. The facility is reserved for Shriners' use on Sundays and Holidays. Weekday rentals may, from time to time, be arranged; coordination is required between Aloha Shrine office and the Beach Club Manager.

Seating capacity is limited to 400 guests as determined by the Honolulu Fire Department. There are tables and chairs available for your use. Tables are long 8x2 Luau style and will seat six comfortably. Chairs are grey plastic fold out style. Renters are responsible for setting up tables and chairs, and general clean-up of the facility prior to departing the premises. There are also two portable bars and several round cocktail style tables available for your use.

Kitchen facilities include gas ranges, gas ovens, and refrigeration and preparation/work tables for your use. Renter supplies own cooking utensils, etc. Guests are allowed to have their own caterers for their function. There is a built-in charcoal grill next to kitchen. Please ensure all the gas ranges and ovens are turned off. All trash must be removed and placed in dumpsters. Be sure to clear the refrigerator(s). Ensure that the kitchen areas, including the sinks are clean. Please do not throw food residue in the yard area.

Children's bouncers may be brought on the premises and limited to 2 without waterslides. Live animals are not permitted (except ponies for children's rides). The manager has the final approval for all equipment, games, toys, etc. Please check with him before committing to any rentals or purchases.

A sound system, imu (traditional earthen oven), and ice are not available.

Inside parking by the kitchen is limited: Check with Manager in advance. Vehicles are not permitted to be driven or parked on the volleyball and play areas in the center of the yard.

Alcoholic beverages may not be sold on the property. Gambling is strictly forbidden.

Open Grills are not allowed in any area other than the Barbecue area.

Baseball, football, golf, bicycle riding, skateboarding and rollerblading are not permitted on the grounds.

No one will enter the pavilion in wet cloths. All sand must be washed off at the outside showers before entering the dressing areas/restrooms.

Rental periods/rates:

8:00 a.m. - 5:00 p.m. \$2,100.00 (Tax inclusive)

10:00 a.m. - 4:00 p.m. a Honolulu Police Officer will be provided, when available to direct traffic and allow guests to cross the highway.

We also require that an event insurance policy of Personal, General Liability and/or liquor liability (if needed) of at least \$1,000,000.00 during the use of the Shrine Buildings, Facilities or grounds which would be the Aloha Shriners Beach Club. Rental procedure:

A \$100.00 NON-REFUNDABLE DEPOSIT is required to reserve your date, along with the completed forms. Once forms and deposit is received, a confirmation will be sent to you. Remaining balance will be due 90 days prior to the event date. Proof of event insurance is due prior to the event date. Reservations are made on a first-come, first serve basis.
